Mercy Health Bright Nights is an amazing light display held over the Christmas season. This display attracts people from several counties to our fairgrounds during the winter as they celebrate the season. Our goal is to make this growing display a destination for families for years to come. Bright Nights was added to the Ohio Holiday Lights Trail in 2021.

A grant from the State of Ohio was secured to dispose of almost 200 tires that have been on the grounds for years. This grant alone saved the Agricultural Society around \$125,000. Additional funding from the state has been secured to facilitate the addition of a couple of new buildings. Replacing the sheep and goat show arena, a new maintenance shop and cold storage facility have been designated for these funds.

Updating the equipment our maintenance staff uses on a daily basis has also taken precedence. We held an auction and sold outdated equipment and in return used the proceeds to order a new Crew Cab 4x4 Pickup Truck and a new Bobcat Skid Loader. We also replaced an additional truck and ordered a new Batwing mower.

With a substantial donation from Nutrien, we were able to replace the plaza stage with a new concrete stage as well as install air conditioning in the Ag and Fine Arts building. The pond in Rocshman Park was drained, dredged, and the rock was replaced making the pond safer and esthetically appealing. Improvements and updates to the grounds are continuous and I strive to keep the momentum going to keep our fairgrounds in top-notch condition and safe for year-round visitors.

I have had the privilege of residing on several committees during the last three years: including the executive committee for two years under two different presidents. I was also appointed the lead director of the sheep department, parade committee, and the concessions committee. While serving on the Entertainment Committee, we successfully returned the car show to the 2022 Allen County Fair. This event was held for many years in the past and I felt enough time had passed to resurrect the show. We set a goal for the number of cars/participants this year and exceeded that goal. Our goal is to continue the show and make it bigger & better in the years to come!

Taking on the role as a Board member of the Agricultural Society and committing 100% to the members and community has been a passion of mine. I made it a mission to attend every meeting and stay engaged in all activities before, during, and after the fair.

I want to thank each and everyone of the Allen County Agricultural Society Board Members. Without you, the Allen County Fairgrounds would not be the venue it is today. I am asking once again for your vote in November. There is still much to do for the future and II want to continue our mission.
